

## US Interruptible Transportation Service (IT-1)— Monthly Bid Notice for April 2025

TSP Name: Alliance Pipeline Limited Partnership

<u>Eligibility:</u> Applicants intending to request IT-1 service on the Alliance US Pipeline and/or Shippers intending to exercise their contractual right to nominate Priority Interruptible Transportation (PITS) volume on their Canadian Firm Full Path Service (FFPS) contract.

All Applicants/Shippers fitting the above description must obtain an IT-1 contract on Alliance. To obtain an IT-1 contract on Alliance, please refer to the RFS (Request For Service) Training material posted on the Open Season link of the Canadian IPS for specific steps on requirements to enter a US IT-1 Request for Service (RFS) through the US Customer Activity Website (CAW – TSP 2000). At a high level, these steps are:

- 1. Ensure that the US shipper/agent/affiliate/counter-party is enabled to access the US CAW.
- 2. If not already created, create a New IT-1 RFS in the US CAW. This is an open-ended electronic contract with the Receipt Location ID of "UX" and a Delivery Location ID of "ACE" which must be created and approved prior to being awarded service. (this step is a one-time step)
- 3. Once approved in Step 2, Applicants are then able to fill out an RFS Interruptible Rate Request on the approved contract for a April 1, 2025 start and a April 30, 2025 end date, a requested quantity, and a bid price at the Tariff Max usage charge of US\$ 0.2662/Dth/d.

<u>Deadline:</u> These steps need to be completed prior to the close of the IT Bidding Window which will be 8:30 a.m. CCT February 28, 2025.

<u>Rate & Duration:</u> Alliance is currently accepting Interruptible Rate Request(s) RFS for IT-1 Service from April 1 to April 30, 2025 that are at the Tariff Max usage charge of US\$ 0.2662/Dth/d.

Once the IT-1 contract is created (pursuant to step 2 above), Canadian FFPS PITS shippers (or their agents/affiliates/counterparties) can then enter the recourse rate and volume that matches their PITS volumes (pursuant to step 3 above).

Capacity cannot be awarded unless the bidder has met Alliance's credit requirements and all other requirements for service in the Tariff.
